MONDAY, JANUARY 22:

EDUCATION

- **OPPOSE**, [HB 1553-FN](#) - relative to establishing a pilot program under the department of education to offer "spelling to communicate" services to students with autism or apraxia.
- **OPPOSE**, [HB 1652-FN](#) - relative to establishing a local education freedom account program.
- **OPPOSE**, [HB 1691](#) - relative to the definition of an adequate public education. *THIS BILL REMOVES ALL CORE REQUIREMENTS FOR AN "ADEQUATE EDUCATION"*

WEDNESDAY, JANUARY 24:

CRIMINAL JUSTICE AND PUBLIC SAFETY

- **SUPPORT**, [HB 1214](#), relative to establishing a committee to study best practices for the development of a restorative justice model for misdemeanor-level behavior and hate crimes committed by juveniles under the age of eighteen.

EDUCATION

- **OPPOSE**, [HB 1161](#) - relative to use of the public school infrastructure fund for energy efficient school buses.

THURSDAY, JANUARY 25:

EDUCATION

- **SUPPORT**, [HB 1176](#) - establishing a commission to study current funding for special education and potential other funding sources.
- **SUPPORT**, [1639-FN-L](#) - relative to children with disabilities placed at state facilities for adjudicated youth.
- **OPPOSE**, [HB 1480](#) - relative to alternative dispute resolution within individualized education programs.
- **OPPOSE**, [HB 1524](#) - relative to authorizing parents of special education children to observe in the classroom setting.
- **OPPOSE**, [HB 1509-L](#) - prohibiting spending of special education moneys for any other purpose and requiring reporting of fund balances to the school board.
- **SUPPORT**, [HB 1469](#) - relative to the retention of individualized education program records.

EXECUTIVE DEPARTMENTS AND ADMINISTRATION

- **OPPOSE**, [HB 1676-FN](#), establishing a sunset commission to evaluate various occupational boards and commissions, and sunsetting various boards and commissions.

LABOR, INDUSTRIAL AND REHABILITATIVE SERVICES

- **SUPPORT**, [HB 1522](#), relative to weekly benefit amounts for unemployment compensation.
- **OPPOSE**, [HB 1519](#), relative to a minor's available work hours.

LEGISLATIVE ADMINISTRATION

- **SUPPORT**, [HB 1363-FN](#) - relative to allowing members of the general court to participate in the department of health and human services employee assistance program.

- **SUPPORT**, [HB 1000](#) - relative to classifying New Hampshire legislators' service as public service for certain federal purposes.
- **SUPPORT**, [HB 1629-FN](#) - relative to attorney general's duties concerning legislators residing in different districts than they represent. *THIS BILL ADDRESSES COMMUNICATION TO THE HOUSE IN SITUATIONS SIMILAR TO TROY MERNER.*
